ORDER

THIS MOTION, made by the Applicants (Respondents in Appeal), DBDC Spadina Ltd. and those Corporations listed on Schedule "A" hereto (collectively, the "Applicants"), for an Order transferring the appeal by Norma Walton, Ronauld Walton, The Rose & Thistle Group Ltd., and Eglinton Castle Inc. (collectively, the "Appellants") to the Divisional Court, bearing Court file number 536/13, from the Order of the Honourable Justice Newbould dated November 5, 2013 (the

"Divisional Court Appeal") to this Court, and for an Order for security for costs of both the Divisional Court Appeal and the Appellants' appeal to the Court of Appeal for Ontario, bearing Court file number C58024, from the Order of the Honourable Justice Newbould dated November 5, 2013 (the "Appeal"), was heard this day at the Court House, Osgoode Hall, 130 Queen Street West, Toronto, ON, M5H 2N5.

ON READING the affidavit of Kearren Bailey sworn March 25, 2014 and the exhibits thereto, the factum and book of authorities of the Applicants, filed, and upon hearing the submissions of counsel for the Applicants, and Norma Walton personally;

- 1. THIS COURT ORDERS that the Divisional Court Appeal shall be transferred from the Divisional Court to this Court.
- 2. THIS COURT ORDERS that the Divisional Court Appeal shall be heard together with the Appeal on May 21, 2014. Only the materials filed by all parties in connection with the Appeal, as well as the factums filed by the parties in connection with the Divisional Court Appeal, shall be used for the hearing of both the Appeal and the Divisional Court Appeal.
- 3. THIS COURT ORDERS that Norma Walton shall, by Friday, April 11, 2014, provide to Lenczner Slaght Royce Smith Griffin LLP ("Lenczner Slaght"), counsel for the Applicants, cleared, certified funds in the amount of \$12,500 (the "Funds") by way of security for costs of the Appeal on behalf of the Appellants.
- 4. THIS COURT ORDERS that if Norma Walton does not provide the Funds to Lenczner Slaght by 4:30 p.m. on April 11, 2014, the Appeal and the Divisional Court Appeal shall both be permanently stayed.

5. THIS COURT ORDERS that the Funds shall be held by Lenczner Slaght in trust, subject to

the terms of this Order or further Order of the Court.

6. THIS COURT ORDERS that, in the event that this Court orders that the Appellants pay

costs in connection with the Appeal in excess of \$12,500 to the Applicants, Lenczner Slaght shall

pay the entirety of the Funds from its trust account to the Applicants, in partial satisfaction of such

costs Order. In those circumstances, the Appellants shall remain liable for any costs ordered to be

paid by the Appellants to the Applicants in connection with the Appeal in excess of \$12,500.

7. THIS COURT ORDERS that, in the event that this Court orders that the Appellants pay

costs in connection with the Appeal in an amount up to \$12,500 to the Applicants, Lenczner Slaght

shall pay such amount of the Funds as ordered to be paid by Appellants to the Applicants in

connection with the Appeal from its trust account to the Applicants, in satisfaction of the costs

Order. In those circumstances, Lenczner Slaght shall return the balance of the Funds to Norma

Walton within 10 days of the date on which this Court orders the Appellants to pay costs in

connection with the Appeal in an amount up to \$12,500 to the Applicants.

8. THIS COURT ORDERS that, in the event that this Court does not order that the Appellants

pay costs to the Applicants in connection with the Appeal, Lenczner Slaght shall return the entirety

of the Funds to Norma Walton within 10 days of the date on which this Court makes an Order

dealing with the costs of the Appeal.
