Gerrard Church 2006 Inc. hereby authorizes and directs you to deal with the gross proceeds of the refinancing of \$750,000 as follows:

- 1. Pay the mortgage agency fees of \$33,900 (\$30,000 plus HST);
- 2. Pay the lender's disbursements and legals of \$16,950 (\$15,000 plus HST);
- 3. Pay to the second mortgagee, 2313778 Ontario Limited the sum of \$139,209.90;
- 4. Pay to Goodmans LLP the sum of \$50,000;
- 5. Pay to Schonfeld Inc. the sum of \$90,000;
- 6. Pay to Cohen Sabsay LLP the sum of \$67,800 (\$60,000 plus HST);
- 7. Pay to Froese Forensics the sum of \$101,700 (\$90,000 plus HST);
- 8. Pay to BTY Group the sum of \$101,700 (\$90,000 plus HST);
- 9. Pay to Intrepid QS the sum of \$16,950 (\$15,000 plus HST);
- 10. Pay to CMLS Financial the sum of \$71,655.32;
- 11. Pay to trades, as directed by Gerrard Church 2006 Inc., the sum of \$56,500 (\$50,000 plus HST);
- 12. Pay the interest adjustment on the mortgage to July 15, 2014 (approximately \$6,250); and
- 13. Pay the balance towards Gerrard Church 2006's legal fees and disbursements.

The Respondents will have to make up any deficiency to cover the above payments.
